Declaration of Principles

"To be nostalgic for your country, living in your country, nothing is more bitter".

Our country is going through the worst supplements in its recent history. Wounded, humiliated, with a numbed conscience and without a compass for its future, it is heading towards its spiritual, biological and territorial self-destruction:

Spiritual self-destruction: the mockery of faith and the values that unite us, the suspicion of self-evident patriotism, the sidelining of legitimacy by impunity, the perversion of education into a vulgar mincing machine, the distortion of political institutions into an immoral shadow theatre - and worst of all: our young people growing up without dreams.

Biological self-destruction: hatred of the indigenous Greek and his traditional family, the loss of the sanctity of gender and procreation, economic poverty crushing children and emigrating our young people, and their place being taken not by persecuted refugees but by illegal uninvited settlers.

Territorial self-destruction: our land to be left bare and fed with loans, our countryside to be deserted, the wealth of our country to be sold off for a plate of lentils, every hungry would-be predator in the Aegean, Thrace, Cyprus, Epirus and Macedonia to be discouraged, and our "leaders" become irresponsible patriotic traders of the treasures of our history and of the Greek nation outside our borders - finally, the Greek becomes an outsider servant with an expiration date, instead of a lord of his country.

In all the sad state of our country, the only happy and comfortable ones are the big gangs of the partyocracy. Behind their individual party masks, every free-thinking citizen perceives as the main culprit a single cancerous occupational system, the "**party of political parties**", which operates under the leadership of ruthless agents of globalisation and with the direct accomplices of the people who are comfortable with clientelistic relations. Many of us who, with a paralytic mentality and a paralysed mindset, are the moral perpetrators of this downward spiral.

victim, we watch the backstabbing in our country, in our society, in neighbourhoods, reacting only as units or as anonymous, unconvinced people. We were content to live as spectators in an unrecognisable pseudo-hell, with which we never agreed.

But fortunately there is another Greece. The Greece of our souls, which throughout the centuries has diligently deposited its sweat in hard work, its blood in the graces, its respect for the iconostasis. The Greece that honours its ancestors and does not forget their struggles, that protects its children and does not send them away, that is accustomed to giving but not to be given away. We are all of us, children of this Greece, of Romanism.

Neither left nor right - but forward. We respect our roots and therefore we could not be radical. We refuse to preserve the old man - the comfortable, the disrespectful, the cunning - and that is why we feel truly progressive and deeply revolutionary.



In the Greece we envision:

- **We want to live off our own land, with our own hands and our own minds, and not with fake and borrowed money.**
- **We embrace and evolve modern technology to make it more human.**
- **We respect and demand respect for all, without confusing all kinds of "rights" with disrespect and unworthiness.**
- **We teach our children first the language of virtue, honesty and legitimacy, and then fearlessly all the languages and arts of the world.**
- **The state is a guarantor of justice, dignity and development for all its citizens.**
- **We build beneficial international alliances, not as a refuge from fear, but with the health of our increased power - economic, military, cultural.**
- **Neither Euro-lagans, nor Europhobic towards the economic giant and intellectual dwarf called Europe.** We reject lobbyings, the colonialist type of "solidarity", the "multiculturalism" of Islamism and immorality. Our European perspective is based on our natural and historical comparative advantages: **We bring Europe to life with intellectual culture, with quality food, with energy abundance, not with settlers and loans.**

For the purpose of WINNING Hellenism and Human Dignity,

we are united in a quality, modern, serious and unifying political organisation, well-meaning people from all strata of society, from all classes and professions: workers and businessmen, students and pensioners, artists and military, teachers and athletes, farmers and scientists, fine people of the Diaspora. Our unifying character, however, is distinctive: our effort is not open to former MPs and government incumbents, regardless of place - we will not burden our effort with the stigma of parliamentary votes and political choices in which we did not participate.

We are not a personal party. The health of our effort is a united group with a common spirit, above individual "saviours".

We are not an association of wishful thinking. Our political thinking combines timeless values of Hellenism and Romanism (existing long before the "left" and "right") with a modern technocratic perspective.

We are not opportunistic political professionals, but politically-minded, hard-working professionals, who would gladly stay at home if the Homeland and the future of our children were in reliable, capable and virtuous hands. We avoid being corrupted by the passions of power, keeping decision-making separate from public representation.

Evil will only triumph as long as good remains inactive. We have no right to fail. We call on every citizen who shares our anguish and our vision to support the healthiest effort to build a Greece worthy of our children. **The WINNING of Hellenism and Human Dignity, can only be "out of the bones of the holy Greeks" and with the blessing of the High General of the Nation.**

NIKE's Objective: the abolition of partisanship!

The beginning of the national plague: "The party of political parties"

The Constitution (Art.26) provides that the organisation and activity of political parties must serve the free functioning of the democratic state. On the contrary, today's party system is the system that facilitates the international enslavement of our country, the systematic rise to power of incompetent or dependent politicians who put party interests and the likes of their leader above the national interest. Today the parties:

- They are a financial plague for the country (subsidies, loans without repayment or return).
- They are falsifying the representation of the People. A worthy person of a district must join the party clique to be elected - and if he dares to disagree with the leader, he is disqualified.
- They are arch-centric, facilitating central control by foreign centres of power.
- They put party interest before national interest.
- They are breaking their campaign promises and voting with "letters" and not with a conscience.
- They systematically put in power a clique of close-knit families who interconnect with each other.
- They influence the executive, the legislature, the judiciary as well as the press, the armed forces and the security forces, trade unions, the public administration, having violated any notion of separation of powers. They have recently gone so far as to put themselves above the law by voting for amnesty!

NIKI stands for a great change for our country: liberation from partisanship.

The Constitution states that "All powers derive from the People, exist for the benefit of the People and the Nation..." (Article 1). Yet! The Greek People have never been asked about the Memoranda, the Prespes, the EEZ, the health freedoms, the discrimination against them, the insult to their institutions, the explosion of crime and the violation of their national sovereignty, the trivialization of their labour rights. All this was done with systematic violations of the Constitution, general silencing and impunity.

- Those who have served in governments, parliament and the European Parliament will be held accountable for all the harm they have done to the country and the people. Their right to re-election will be restricted, putting an end to the perpetual professional politicians.
- Thorough financial audit of the parties' finances and the imposition of the repayment of their debts to the Greek people. Abolition of the huge subsidies to the parties.
- Liberation of meritocracy in the , the Armed Forces, the Security Forces and the Public Administration, with the abolition of party appointments.
- Liberation of trade unionism and student organisations from party domination.
- Criminalisation of clientelism. Those who "eat together" will be held accountable together.

More direct democracy, new electoral law.

- New electoral law for direct election of MPs by the people. Each province/parish will elect a fixed number of its own representatives to Parliament, with no minimum nationwide party performance. Power to the voice of the Greek Diaspora, which will elect a fixed number of its representatives.
- The Legislative Assembly of the Parliament will therefore be composed of people who have been directly elected, without "left-wing" or "right-wing" agendas based on their good record in the society that knows them and not on deals with party cliques.
- In this way, the influence of foreign centres of power is made more difficult by controlling the votes in Parliament, without the "party line" that today can be imposed by a controlled or blackmailed party boss.
- This also means that the election of the President of the Republic by MPs and not MPs of party lines, will enjoy the love and trust of the People, without the suspicion of transactional relations with party mechanisms.
- Voting is a sacred choice and it is not a matter for intermediaries: Counting in a simple and traditional way and not by information systems.
- More frequent with clear political questions, and with the result binding on the government.
- Drastic reduction of the number of MPs to 200 (minimum constitutional limit). The resources saved from 100 fewer MEPs (salaries, benefits, expenses, offices, staff appointed or dismissed) will be symbolically allocated to needy Greek families.
- Protection of the free will of the Greek People from the systematic population falsification illegally imposed by the parties in power: Instead of Greekization, "metikou" status for legal immigrants, with full respect and civil rights but no voting rights. Greek deputies should be children of the Greek people, and only children of the Greek people, as the Constitution (Article 51) stipulates that "The deputies represent the Nation".

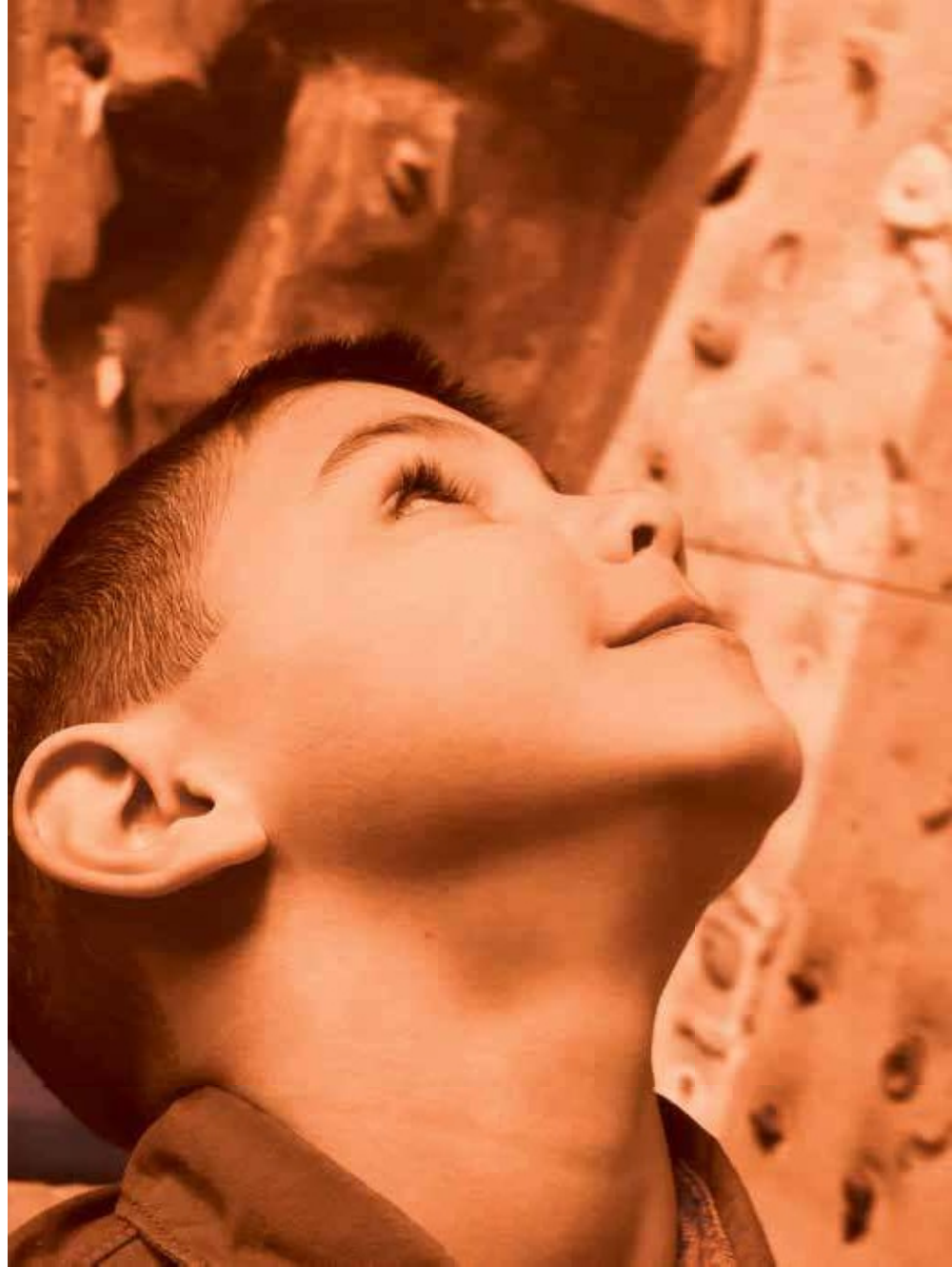
The Objective Purpose of NICE is the best guarantee of our political Credibility!


- By aiming to minimise the irrational influence of the parties in the state and society, by electing MPs without party mechanisms, we are by definition confronting the interests of all the parties in parliament. We burn the bridges for "collaborations", "tumbling" and "transactions" with other parties, and therefore we do not distort the trust that the Greek people will show in NIKI.
- NIKI is not asking for a protest vote aimed at a temporary bourgeoisie of a few seats - it is directly aimed at rising to power and the legislative minimization of partisanship. Until it realises its objective with the necessary legislative reforms, NIKI is calling for a mandate to govern on the basis of its political programme.
- When it achieves the minimization of the influence of the parties, NIKI itself, which will by then necessarily have a party mantle, will be led to its own similar minimization, proving that it is not overwhelmed by the scourge of power. But it will have delivered two great legacies:
 - To the Greek People, a more dignified Homeland and a more democratic way of electing and operating the legislative power, in which active citizens will be attracted and capable, honest and unbiased children of our People will emerge.
 - To the peoples of the world, a signpost to liberate themselves from the shackles of partisanship.

Education

The country that gave birth to education is today slowly killing it. Children ignorant of the wisdom of our ancestors, adolescents who are functionally illiterate and unprepared for the difficulties of life, students saddened by uncertainty, teachers trapped in financial poverty and with half-quenched flame for the best, parents overwhelmed and unmotivated in the management of their children.

- Language from the treasures of our literary treasures, simple ancient Greek from primary school, religious education as provided for in the Constitution, history as patriotic knowledge and the teaching of characters and values.
 - New courses in Logic, Practical Economics, Physical Health to enhance practical skills.
 - The embellishment of student life with performances and practices of responsibility and teamwork from our living heritage.
 - Parenting School for healthy counselling for each child instead of group sex education.
 - Special mobile phones for students: Greek-made, low radiation, low cost, with educational applications and no social media.
 - Focused care for children with autism and special education needs as well as children with advanced intelligence, full-day activities for children growing up with one parent.
 - Respect for Teachers by revising the yearbook and additional support for effective teaching.
 - Higher education with a preparatory first year, for less stress and better targeting of schools.
 - Student Shield programme to support diligent and systematic study, with fair grading, financial aid, and academic asylum as an exclusively legal expression of ideas.
 - Evaluation of universities based on the professional development of graduates.
 - Strong postgraduate programmes in cooperation with foreign renowned universities: free of charge for Greek citizens and an attraction for foreign students.
 - Organic linking of Universities with Research and Development of enterprises and public sector.

Demographics

In the last 50 years, the 150,000 Greek births per year have been halved. Greece claims to have the worst population trend in Europe, with a suicidal combination of under-birth rate, mockery of the institution of the family, emigration of impoverished Greeks and invasion by uninvited settlers. It is criminal to expel the most valuable indigenous European people from their homeland on the cheap excuse that this will solve the demographic problem and pay our pensions better.

"Our vision is a large and dominant population of indigenous Greeks in our country: Greece of 16 million Greeks in 2050".

An integrated solution to our demographic problem means a guarantee of real democracy, sustainable economic growth, stable pensions, health security, social peace and national deterrence.



Integrated Demographic Programme in 4 pillars:

Family

- We restore its sanctity in Education, Culture and Media.
- The only institutionalised cohabitation is marriage - whether civil or religious - between a man and a woman, with equal treatment under general civil law for all unrelated cohabiting persons.
- We differentiate the taxation of grandchildren and agnates to reduce the financial disincentive to create a family.
- We ensure healthy child rearing with a minimum age of marriage regardless of religion, and we tighten the penal code on child abuse. We protect children's innocence from unchecked digital risks.

Maternity

- We protect pregnancy in terms of employment and insurance.
- We provide for a childbirth allowance up to full coverage of childbirth costs for needy pregnant women.
- Redesign and speed up procedures for adoptions.
- A monthly allowance for home care to reinforce the mother's physical presence in the upbringing of the children.

Polytechnique

- Practical reward for the family of the child.
- Preferential housing policy for the region.
- Recruitment costs and immediate priority for teachers.
- Free student transfers.
- Right to work after retirement.
- Enhanced tax-free threshold.
- One-off support from the third child and a monthly allowance for a single mother.

Migration

- Review of all massive domestication.
- Taxing the remittances of migrants abroad.
- Establishment of a Resident instead of a Citizen, with health care and insurance rights, but not political rights (voting and election).
- 46 years of real estate ownership, and residency with monthly mandatory health, employment and criminal record checks.
- A declaration of acceptance of Greek culture, values, language and customs, with renunciation of any intention to make changes in our politics.

Culture



"Our culture is not just monuments and history, but living values, a way of thinking and living - an invaluable treasure for every young person.

The priority and mission of a modern Greek Ministry of Culture is to bring out our virtues and incorporate them into the modern way of life."

- Greek "Hollywood": an entertainment and entertainment industry aiming at the qualitative promotion of aspects and persons of Greek history of international interest.
- We export our children's entertainment, from traditional games to Aesop's fables.
- A digital History Channel for our intangible cultural heritage.
- Cultural grants based on tradition and youth participation.
- We are establishing standards of traditional building sensibility across the country.
- International tourist promotion of Greece as the No.1 pilgrimage destination for Christians in the East and West, as a hub of Apostles, Saints but and the Eastern Roman Empire, the world's first Christian civilisation.
- Digital History Guide: we create roads and paths of culture in every corner of our country, with a mobile application, freely accessible and with automatic translation in the language of each visitor.
- We promote the Ancient Greek Language: international examination certification for learning Ancient Greek, membership in Google's automatic translator, annual festive and competitive events, camps for children of expatriates and friends with a fast-track introduction to the Greek language and Greek culture.
- We are pushing and organizing lobbies returning all our prominent supporters for the repatriation of our stolen antiquities.
- We are putting a decisive barrier to the projection of vulgarity - moral, linguistic and historical - by controlling the suitability of children's games and programmes, by linking television content to tax incentives, by establishing a Linguistic Commission of Neologisms and a Scientific Truth Service to protect historical truth and the international reputation of our country from the psychological warfare of foreign propaganda.
- We include the ancient Greek pankration in the internationally certified martial arts.
- Free access to archaeological sites for every low-income household.
- Decorating public spaces with didactic sayings and praiseworthy deeds of our wise men, fathers, heroes.

Foreign Policy

"Neither Westphobic nor Westphobic. With a strong patriotic stance in international organizations and a survival doctrine of Preventive Deterrence, we focus on domestic strength and multiple alliances."

We respect international law but we know that strength and determination dictate it.

The defeatist appeasement, the uncritical assignment of our rights to the goodwill of third parties, the baptism of inferiority as an "honourable compromise" is the failed doctrine of decades of Greek foreign policy.

The dominant Balkan problem is the Muslim arc of neo-Ottoman Turkey. It has only ONE stopping power: Orthodoxy.

By cultivating a unifying consciousness of a common Orthodox heritage, without the thorns of pan-Islamism and pan-Slavism, the Balkans can become a focus of stability and security, valuable both for the US-Russian balance and for the energy balance.

and population protection in Europe. Our vision of an orthodox Balkan hinterland requires good, clean relations with our neighbours.

Macedonia is One, and it is Greek - ethnically, linguistically, geographically.

The treacherous Prespa agreement is based on lies that even the Skopjeans do not believe. With Skopje, we must find a clear, dignified name and structure a sincere friendship based on Orthodoxy, granting dual citizenship to the 100,000 indigenous Greeks who have been historically recognised by Tito, the Germans, the Americans, Gligorov, but not by the Greek governments.

With Albania, the key to progress is the return of the North Epirotic Hellenes to their ancestral land.

The return of North Epirus Hellenism means interest-free investment loans, but also a shield to protect it against all threats: the violation of rights, Islamic colonization, the looting of monuments, the lies in Albanian textbooks. Implementation of Albania's international commitments (under the Corfu Protocol and entry into the OSCE) which provide for stronger Greek claims in the North Epirus than those already claimed by Albania in Kosovo. A crackdown on the claims of the Chamidi collaborators of the Nazis, but also on organised and state-interlaced crime from the trafficking of human beings and drugs, through the taxation of remittances and border controls.



Turkey has no history but a criminal record, and in the "dialogues" it has shown that it understands only the language of Power. Let's talk to her!

- **Increased operational capacity:** Palliative defence on our border islands, paid extension of service, new smart armaments, development in defence bio-engineering, boosting civilian morale, diplomatic preparation for a possible pre-emptive strike, development of cyber warfare strategies.
- **Real Diplomatic and Economic Pressure:** Official declaration of our EEZ at the UN, halting Turkey's EU accession process and suspension of the EU-Turkey customs association, pressure for an international travel directive in Turkey, following the offensive conversion of Christian monuments into mosques.
- **An integrated solution for our free Thrace:** Closure of the Turkish outpost in Komotini. No tolerance to any participation in events on the subject of the Turkish people. "autonomous western Thrace". Inclusion of Pomak language education students in linguistics curricula of Greek universities. Equal recognition of the Pomak language in minority religious schools. Programmes

economic support for the Roma and Roma. Strengthening, organising and properly staffing the official minority institutions controlled by the state (mufti, administrative committees, seminaries). Stability and full respect for the appointment of muftis by the Greek state.

Martyred Cyprus is NOT far away, but has an eternal and indelible Greekness.

The problem is not only Turkey (invasion, war crimes, pseudo-state, illegal colonisation, attempted theft of EEZ) but also the inability to enforce the law. The multifaceted alliance between Cyprus and Greece with the vision of a functional Union not only responds to the national interest and the historical struggles of the Cypriot people, but is an achievement that would dramatically increase the influence of the united Greek nation in the Eastern Mediterranean.

National Defence

"Let us allow our Armed Forces to finally do what they are there for."

Respect for the Armed Forces

- An end to the sick political-military relations of retirements and dismissals, indifference to the lack of resources, disrespect for the traditions of the N.D., the "phone calls" of politicians to administrative decisions.
- An end to the diversion of the EDs from their mission. The military is not a soup kitchen or a hotel for illegal settlers. And unionism is outside any military ethics, since the natural hierarchy protects clearly defined rights and obligations.
- Courage and confidence in the relationship between the EU and society: Uniforms are not for the wardrobe, parades are not negotiable.

Increasing the fighting capacity of all. Freedom is not the obligation of others or the responsibility of "experts".

- The Evelides, Cadet and Icons Schools to produce Military Leaders, not academics.
- Tenure: mutual benefit for the young person and the Homeland.
- Investing in Professional Armed Forces: direct recruitment, extensive training, bonus for recruitment in public/UTBs.
- A new doctrine of popular defence: a clear message to every citizen, strong morale, protection from false news and from the propaganda of ideologies that distort patriotic sentiment.

Functionality and Reorganisation

- Focus on combat mindset, realistic training on the principle of "train as I will fight", appropriate operational equipment.
- From the opportunistic CSCE to the functional permanent National Security Council.
- Reorganization for the operational response to the now multi-faceted Turkish threat (from the Greek-Albanian border, from internal hybrid attacks, in the Greek-Cypriot common area).



Serious Greek Defence Industry

- Defence procurement with the participation of Greek units as a prerequisite.
- A healthy management and operating environment for all Defence Industry Units under a single institution - with clarity, away from partisan entanglements and bureaucracy.
- Focusing on objectively profitable Units, supporting them with the necessary infrastructure, quality staffing with incentives for the repatriation of researchers, scientists and technicians.
- Institutional Research and Development network (research centres, universities of technology, public and private industry). Public-private partnerships for the construction of ships for the Navy.

Redesigning the Thesis: Qualitative and useful for every New, Substantial and sufficient for the Homeland.

- The State's active respect for the time of the citizen, with full utilization of the time of service without exhausting extra work, with the recognition of service as pensionable time,

increasing the financial assistance of the conscript soldier, life-long training: first aid, living in nature, dealing with emergencies.

- Paid voluntary extension of the term of office for 1-4 semesters, with a public/UTO grade.
- Service as an integral stage of childhood: Close cooperation between the Ministries of National Education and Education. Close cooperation between the Ministries of Youth and Education for a smooth transition to the age of 18 after the results of the examinations, with multiple advantages for the young person (direct link between the completion of studies and professional rehabilitation), for the Armed Forces (increased strength without leaks, high physical endurance and ease of training), for society (more mature and more responsible citizens).
- Increasing the manning and readiness of the Units with progressive adjustment of the term of service according to the needs of the Armed Forces.
- "Legion of the Homogeneous": providing study and tax incentives to 2nd generation Greek expatriates for service in the Homeland.

Strategic Economy

*Honesty, Freedom, Dignity:
are not only moral values, they are also economic terms.*



Neither right nor left. A strong economy needs the whole of society.

- Practical Dignity for the Worker - with the restoration and protection of labour rights.
- Respect for the Entrepreneur - with low taxes.
- A "big" state in social interaction and the service of the citizen.
- A "small" state to make room for private entrepreneurship and innovation.

European Union and the Euro

- There has never been a serious economic and technical study either for the entrance or for our much-discussed exit. Without a strong economy, "leaving the euro" simply means "changing big money". **So our strategic priority is national self-sufficiency in food, energy and medicines.** Only then will we have the responsible freedom of choice "in or out".
- Liberalisation of our primary production, compulsory participation of Greek companies in major public projects, priority in energy production.
- With no illusions about the myth of "European solidarity", we do not give away benefits to the grabbers of our national wealth: we demand war reparations from Germany, we denounce the EU-Turkey customs union, we restore a positive balance in the economy of northern Greece by countering the aggressively taxation of neighbouring states.

Respect for public and private resources.

- Accounting control of the foreign borrowing and debt of the opposition governments, abolition of long-term rents for the housing of public services, property control of the "big guns" of the market, who have become personally rich, leading customers and suppliers to ruin.
- Those guilty of theft or damage to public property will be compensated up to and including confiscation of property.
- Historical monuments and resources related to national security and public health are outside the jurisdiction of the Hellenic Property Fund. In all other respects, priority is given to buyers who are Greeks of the Greek community, and with a business plan that is staffed 60% by Greek employees.
- It is the duty of the State to shift the catalytic preference to sectors with multiplier benefits for the economy, putting an end to the parasitic economic model where production units and schools are closed down, while casinos and slums are opened.

What went wrong?

On the inside, sneaky: We have restored ourselves to European subsidies, we as a society have devalued the value of being a producer, our cooperatives have become laboratories of partisanship and convenience.

Abroad, they're sneaky: We have ceded to the European Common Agricultural Policy the right to impose unfavourable high-cost standards on our agricultural production, while the economy of production is further distorted by black labour, the low bargaining power of producers in the distribution

networks, competitive pressures within and outside the EU.

To build robust, healthy alliances of farmers, manufacturing companies, research centres.

- Liberation of cooperatives from party rule: legal flexibility for cooperatives to determine their own organisation and operational direction.
- Financial incentives, capacity building and managerial electrical applications for participation in cooperative schemes.
- Extroversion of synergies by exploiting joint marketing, distribution and marketing networks.

To build the bridges that will unite the young people with the Greek land: Love, resources, infrastructure, guidance, prospects for a profitable livelihood.

- National education and media oriented to instil love and respect for our "unknown" primary sector.
- State development bank for interest-free financing.
- A framework for advisory professional support for young farmers.
- Digital platform of the OAED for finding seasonal agricultural work and combating black uninsured work.
- Removal of EU restrictions for maximum production of Greek products with comparative advantages (olive oil, wine, dairy products, etc.).
- Strengthening the commerciality of the primary sector by:
 - > Reduction of energy costs in primary production (18% of total inputs today) through cost subsidies or energy self-sufficiency.
 - > Establishing minimum producer and retail prices, encouraging preference for quality Greek products.
 - > Full utilisation of water resources through irrigation infrastructure projects and desalination plants for irrigation in island Greece.

National Agricultural Development Plan: The focus is on the farmer and his relationship with the land.

- Digitisation of agricultural production in the context of intelligent agriculture.
- Geographical production zones for traditional and innovative products.
- Fighting the black economy, with tax breaks and an income tax system based on incomes.
- Central planning of agricultural production by region based on the real needs of the economy and the market.
- Continuous educational flow of knowledge and information to young farmers, advice on quality systems and organic farming.
- Creation of a national seed bank, reintroduction of production with natural seeds that are transplanted and reproduced, not with sterile, genetically modified, disposable seeds.
- Food crisis response and management mechanism with appropriate sub-structures (regional cold stores - warehouses)

We import an unacceptable amount of meat, dairy and fish products instead of producing them.

- Subsidy programme and domestic production of animal feed.
- Exclusive supply of Greek animal feed / dairy products for feeding in all activities funded by the state (hospitals, army, schools, public tourism, etc.).
- Intensive quality and "Greek quality" controls on animals or meat.
- Modernisation of obsolete slaughterhouses. Greece has 136 slaughterhouses compared with only 8 in the Netherlands.
- Protection of quality Greek fish farming from unequal competition, as the EU obliges it to strict and costly standards, when the EU allows competition from third country products without costly rules.



State and Administration

"Cleaning up Greek political life means an end to irresponsibility and, at last, separation of State and political parties".

Political Responsibility of Ministers and Members of Parliament.

- In full analogy to the consequences faced by anyone who breaks his promises to an employer, bank or military superior, serious consequences should be imposed on anyone who deceives the people during elections and betrays them with contrary actions. The alleged penalty of 'not being re-elected' is not enough.
- Confiscation of property of politicians convicted of scandals.
- An audit of our foreign debt since the post-war period.
- Economic audit of policies: In addition to the "background check", strong taxation on wealth acquired during the

the period of government/parliamentary office.

- Legal control for possible constitutional aberrations during the subordination of the state and national wealth to memorandum regimes, as well as during the signing of transnational agreements that have damaged the country.

Serving in Parliament is not a privilege, but a voluntary service to the People and the Homeland.

- Drastic reduction in the number of MEPs. The European Parliament has only 705 members for a population of 450 million!
- Abolition of police custody of public figures - former and current MPs and

policies; public security is the same for every Greek citizen.

- Parliamentary immunity: exclusively for good service to the country, not for the use of impunity.
- Abolition of automatic pension with two terms of office and abolition of allowances for participation in parliamentary committees - part of the obligations of every MP. Instead of the above privileges, double pay during the parliamentary term, subject to regular attendance in parliament. Substantial incentives are required to work hard, dedicating a productive part of their lives to a high cause.

Put a stop to .

- Upgrading the Ombudsman's role in reporting corruption in the public sector. Legal coverage for wronged low-income citizens.
- Selection of governors of state agencies and institutions from the best, not from the day labourers. Nominations should be made by people who are relevant to the subject, accompanied by a vision, plan and strategy for the institution they wish to take over. Selection by a committee of 'wise' and established experts in the field, while the political leadership and the sectoral heads of the institution would simply have veto rights for objective reasons.

A prison system with respect for the taxpaying citizen.

- The monthly cost of each prisoner is 32% more than the basic monthly salary of a law-abiding citizen! (857€ to 650€)
- Redesign of prisons. Compulsory work and prisoners' contribution to prison maintenance resources.
- Repeal of the Paraskevopoulos Law for the release of criminal prisoners - we do not throw away the Greek people's money that goes to policing, the judicial system, the prison system.

Public Safety.

- The mission of the police is the security of the citizen, not the politician. Freeing the police force from guarding persons to protecting the ordinary citizen.
- Shielding the police officer in the essence of his mission. Ongoing training and equipment upgrades for front-line police officers. Full operational readiness of all patrol cars.
- Abolition of the trade unionism in the Security Corps and in the National Security Service.
- Total dismantling of all "ghettos" of systematic illegality.
- The protection of the home is the highest obligation of a favoured state. Expanding the conditions of legal self-defense within the home. There can be no level playing between the peace-loving landlord-householder and the intruding thug.

Trade unionism: a democratic affair of every worker, not of an "elite" of professional trade unionists.

- Decoupling trade unionism from parties.
- Election of persons, not combinations.
- Establishment of a School of Labour Law, with free, flexible and free education for every worker, as a necessary precondition for a worker to claim trade union duties.



Every vote counts!

"No vote wasted.

Nor to the parties that
destroyed the country, nor to

Four great reasons distinguish NIKI from any other political proposal:

- 1. Really by the People, without professional politicians.**
- 2. With collective leadership, free of arch-mania and cliques.**
- 3. With a clear , the abolition of partisanship and not just "to get into the Parliament".**
- 4. With clear values of Romanism, without "right-wing" and "left-wing" patriots or generalised "patriotism" of dubious other values.**

The coexistence of these four reasons highlights NIKI as the only credible political proposal for every well-meaning citizen who, until today, does not go to the ballot box, turning away from the deceitfulness of the collusion of the systemic parties.

We demand an impartial, traditional vote count. No for less democracy.

We have all heard serious concerns about the inconclusive nature of past elections in our country, such as:

- a) archived appeals of parties that received votes in areas where they did not even have candidates or ballot papers!
- b) unreasonably more registered than the actual population!
- c) addresses legally registered foreigners corresponding to fields or abandoned warehouses!

NIKI wishes to ensure the confidence of the Greek People in the electoral process, with vote immutably imprinted. We call upon the Justice, the government, as well as all the other parties that intend to participate in the elections, in a simple and workable proposal:

The counting results from EVERY SINGLE polling station, which are currently sent digitally only to the Supreme Court, the Ministry of Interior and the private company (currently directly commissioned by the Minister!) that undertakes the collection and aggregation of the results, to be sent simultaneously to ALL participating political parties, and to be posted in irrevocable form on gov.gr, accessible to all taxpaying citizens. Today, IT gives us unlimited information possibilities; let us make use of them!

NIKI demands transparency in the collection and processing of counted votes.

Relations between the State and the Church

"The culture of our Russianness is the best guarantee of human dignity and equality for all".

Orthodoxy is in our cultural DNA.

- Orthodox Greeks, the fathers of 1821, took up arms first "for the holy Faith of Christ" and then "for the freedom of the Fatherland". Their legacy is the reference to the Triune God in the preamble of the Constitution, which is a binding rule.
- The close relationship between the Greek State and the Orthodox Church is an advantage and a national asset. We are not accountable to Europe or to the sophisticated for it.
- The Church must enjoy the undivided honour and respect of the State, as is evident from the Constitution and from the establishment of the Autocephalous Church of Greece.

Religious freedom is a basic human right.

- A new legal framework for the protection of the Orthodox Church or any other known religion from unjust insults and blasphemies.
- Respect by the State for the religious conscience of citizens. It is unthinkable for the State to interfere in the Holy Sacraments, to give opinions on the conditions for their performance, to prohibit them or to allow public persons to express prejudicial opinions about them.
- Respect by the State for the standards for issuing "citizen cards" or police identity cards so that they do not contain offensive and discriminatory markings for Christians.
- Everyone must be able to do so without violence or threat.

can choose the religion they wish. Opposing logics (e.g. Sharia) are unsustainable for the Greek legal order.

- The Religious Education course is confessional according to the Constitution. Heterodox or heterodox students are entitled to exemption.
- The Church Administration should have the exclusive responsibility for the education of priests and the accreditation of religious teachers in schools (as is currently the case in schools of religious communities).



State law and ethics must respect fundamental Christian values:

- The sanctity of human life from the moment of its capture.
- The protection of children from educational promotion of practices and qualities that are incompatible with being a Christian.
- The sanctity of marriage clearly defined as a union exclusively between a man and a woman.
- The consequent raising of children and adoption exclusively in environments that have respected this sanctity of marriage.
- Balanced human development, by harmonising between adulthood, the legal age of marriage, the legal age of consent and the legal age of capacity to make responsible decisions.
- Sunday, as an official holiday per week, as well as the official state holidays, which include the major religious feasts of the Orthodox Church, namely Christmas, Easter, Pentecost and the Assumption of the Virgin Mary.
- The freedom to exercise the liturgical life of the Church as it defines it.

Neither Caesaropapism, nor Papacatism.

- Today the relationships are legally clear. Close cooperation is required for the good of the Homeland. There can be no indifference on the part of the State towards the Church, nor on the part of the Church autonomy from the State or participation of clergy in secular offices.
- The salary of the Orthodox clergy is a commitment of the Greek state, due to the cession of almost all church property to the state after the Asia Minor catastrophe.
- A minimum guaranteed salary regardless of the diocese, especially for priests in residence.
- It is unacceptable and immoral for the state to offer tax-free donations to parties and politicians, but to tax donations to church, charitable and missionary associations.

Employment, Taxation, Insurance, Pensions.

"We must break the vicious circle of mentality where the state is a predator and the citizen is a tax evader. Honest state, honest citizens."

Priority to full employment that creates free and happy citizens. Unemployment and part-time employment produce poor and frightened citizens, ready to give up their country and dignity for a little shelter and a few crumbs.

- A new mission for the OAED: the best, smartest and most modern job search engine, with priority given to low-medium education and skilled workers.
- Unemployment and air sickness are treated differently. An unemployed person who refuses employment offered by the OAED while

meets the criteria, will lose the right to unemployment benefit.

- A 25% increase in hourly pay for part-time work compared to full-time work, and lower employer contributions for full-time work: Incentive for businesses to work full-time, but also improve the finances of those who remain part-time.

Labour rights in the 21st century must remain a basic human dignity and not a memory.

- Sunday is a holiday. It builds family cohesion, good working relationships and a good working relationship.

psychology, the protection of the small family business against unequal competition.

- Practical safeguarding of labour rights. Flexibility does not mean equality.
- The home is a sanctuary and not a mandatory workplace.
- Rolling staff at the Labour Inspectorate, for anonymous and intact checks.



Taxation focused on the creation of Greek jobs, the strengthening of Greek production, small and medium-sized enterprises, the protection of small and medium-sized property.

- Reduction of over-taxation on small and medium-sized Greek businesses, and abolition of advance taxation.
- Simplification and long-term stability in taxation.
- We protect the freedom of property ownership. Total abolition of ENFIA on small property, and the tax remains only on large property when combined with high incomes.
- Revitalization of Northern Greece and restoration of productive headquarters from similar states, with tax-balancing incentives.
- Foreign investment with mandatory recruitment of at least 60% of Greeks.
- Low taxation for the transfer of tax domicile of foreign companies to Greece, as long as they invest in the country.

We secure the pensions of our loved ones by strengthening legal employment, cracking down on uninsured work, and attracting economically active Greeks from abroad.

Old age is the silent root that still holds family and social cohesion together, actively supporting the unemployed and working mothers. Let us recognise this and give it the dignity it deserves. It is barbaric, anti-national and an insult to our intelligence that some people are trying to convince us that our old people's pensions will be paid by illegal immigrants.

- Significant penalties for uninsured work, both for the employer and the employee.
- Incentives for the repatriation of Greeks who have emigrated in recent years, as well as for the repatriation of 2nd and 3rd generation Greeks, with preferential terms for employment contributions and business investment.
- Incentives for new graduates to stay Greece, by providing preferential conditions for their start in the workplace: low employer contributions and low-interest financing for new businesses for the first two years after graduation.
- Saving part of the employer's contributions in a special investment fund so that pension contributions can also have a contributory character.

A healthy mindset in economic activity

Healthy consumer behaviour

- 1 in 7 euros of our economy is estimated to be spent on addiction industries. More than ever, we need higher consumer, economic and environmental intelligence: first learn to be frugal, then reuse, then recycle.
- Valuable school knowledge and experience will allow our children to live better with less: Nutrition and basic cooking, household repair and maintenance skills, money management and saving, experiential philanthropy, the difference between easy money and honest money.

Healthy working behaviour

- Redistribution by law of part (e.g. 15%) of the profits of companies to employees - an incentive for employees to do their best, and for employers to operate more freely and more cooperatively with their employees. The competitiveness of the Greek economy will rise sharply and poorly conceived trade unionism will gradually disappear.

Honest state towards the citizen

- Timely issuance and timely termination of pension rights.
- Equal treatment in transactions between private and public entities. Not interest-free for public debts but interest-free for the citizen!

Protection of Property

- The Hestia of every Greek is sacred. Abolition of the ENFIA, which is tantamount to criminalising property, and a focus on a completely fair levy on multiple property rights when combined with high incomes.
- No tax on the parental transfer of a primary residence.
- No Greek homeless. Housing and work centers for every homeless person. Every homeless person will contribute with his/her work to the cost of its maintenance.

"We want not only a bigger GDP, but also a higher quality GDP. With respect for human dignity."

"Banks need to remember their healthy mission: to strengthen the economy and entrepreneurship."

Monetary economy, real money.

- From capital controls to click-to-buy, even the simplest transactions are becoming immaterial and digital, passing through the hands of banks. Legally issued money is practically abolished, the free, commission-free circulation of money is violated, and institutional power is given to private individuals. Thanks this state coercion towards a bankrupt society, banks compete with no one to gain access to the saved sweat of households, offering non-existent interest rates.

The public sector belongs to us - we respect it like our home.

- It is unthinkable for the State to own significant real estate and at the same time pay private individuals rents to house its services.
- The theft of public funds, in addition to the criminal penalties

consequences, must be treated with full compensation of the value.

- TAFED: Immediate exclusion of archaeological and historical monuments, items related to national security and public health. Priority to buyers from the Greek community.

Healthy lending

- A new system for banks to evaluate lending, focusing on the health of the business plan, with the advice of the National Business Council. The current disregard for the business plan itself and the single-minded focus on loan guarantee shows a focus on failure - a mentality that belongs to loan sharks, not sound bank investments.
- Prohibition of sale/transfer of the loan to a creditor on different, extortionate terms from the original ones, even without the borrower's knowledge.

- No foreclosure of first home due to a red loan. Distinction between actual distress and malice: Mandatory work in the wider public sector for the debtor, with a special scheme of increased deductions aimed at sub- debit long-term loan servicing on decent terms - i.e. viable repayment for any well-meaning debtor, and forcing the malicious one into a repayment arrangement so that he does not change his occupation and net earnings.
- The first beneficiary in bankruptcies are the ordinary workers. Then the state, the suppliers and lastly the banks. The current reverse order is immoral, inhumane and damaging to the economy.
- Conduct an audit of the ownership of the Bank of Greece and the systemic banks in order to identify over-concentration of shares in legal entities.

Entrepreneurship, Innovation, Industry

"Greek entrepreneurship thrives abroad and is buried in its homeland. This must change radically and immediately."

Creation of a National Council for Entrepreneurship:

- Coordinates all individual entrepreneurship development initiatives ("Innovation Ambassadors Network").
- It provides close supervision and advice new businesses.
- Evaluates business efforts (new or expanding) based on the actual dynamics of their business plan, with priority given to the export character.
- It is the reference point to which banks will turn for a valid assessment. This radically revises the assessment of investment lending on the basis of the business plan.

- It provides interest-free financing with a mix of bank participation, and direct crowd funding for the safest investments. The financing fee will not come from interest but from a share in the revenues/profits of the venture.

Network of Innovation Ambassadors for Greek innovative business ideas and startups.

- Management by a select body of Greek and Greek businessmen, politicians, university and research centres, with the participation of ministries according to their specific interests (primary industry, transport, tourism, defence industry, etc.).
- Geographically dispersed throughout the country, each Innovation Vault will offer: Free hospitality (offices, infrastructure) for startups. Free consultancy, access to specialised know-how and registration of industrial property. Regional meetings with industries, companies and investment networks for the presentation and commercialisation of innovations.

"The Greek economy in Greek hands, for a better standard of living, a sustainable income that will reinvigorate the Greek economy, creating stable new jobs."

"Entrepreneur's Advocate"

- Identifying and solving problems faced by businesses, mainly in their transactions with the state, in order to combat corruption.
- Operation as an investment service centre with special branches at the Greek Embassies, with the aim of identifying and drastically solving bureaucratic problems in the implementation of investments.

Creation of a market hinterland for good Greek products.

- Export Economic Diplomacy: Positioning and evaluation of embassies and diplomatic corps based on the implementation of export agreements in the countries where they operate.
- Cooperation with the Hellenic Diaspora to channel Greek products to the five continents.

- Large Corporate Customer Service with the participation of the Ministries of Development and Foreign Affairs. Direct negotiation of large-scale commercial partnerships for Greek products and services.
- "The insisting Greek, part 2": special labeling of products that incorporate more than 50% Greek added , so that their consumption increases taxable income.

Industrial growth in critical sectors

- Drastic reduction of bureaucracy
- No public sector project award without a partnership with at least 50% participation of a Greek company.
- Pharmaceutical industry: Incentives for domestic production of essential and widely used pharmaceutical goods.
- Automotive industry: Direct negotiation

with the major car manufacturers for production plants.

- Clothing, Footwear: Greek industries with a Greek workforce as exclusive suppliers of clothing and footwear for the army, security forces, school clothing, public sector workers, local government.
- National research and development for the military autonomy of the Greek islands in terms of drinking water.
- Incentives for setting up businesses in the countryside to save the countryside
- Greek co-production mobiles for students: Safe to use, no social media, with educational applications, low cost.
- Strong shipbuilding sector with tax exemption on purely Greek owned shipyards.

Health

"High quality public health care for all Greeks, without underground economy: A bet of moral culture, national cohesion and social solidarity."

We have a system, we don't have health care!

- The poorest Greeks are suffering for access to health services. Unacceptable percentages of cancer patients and diabetics have no money for a doctor or medicine.
- Poor health of the average Greek, hence expensive health services.
- Depression of the quality of services during the decade of the memoranda: a 40% reduction per capita public health expenditure, with a 30% increase in patient discharges due to uncontrolled illegal immigration.
- Poor geographical distribution of hospitals and primary health care units.
- The absence of organised and modern primary care (home care, day-care units, day-care centres, rehabilitation centres, units for the chronically ill).
- Partisanship in the NHS, with the transfer of powers from hospital administrations to party people.
- We have proportionally the fewest patients and the most doctors in the EU, with 1 in 4 members of the Medical Association

Athens unemployed or underemployed.


- The time bomb in the health system is the exodus of young people, under- birth rate, over-indebtedness, obsolete prices.

Primary care means better health in our everyday lives.

- Family medicine team instead of a family physician.
- 8 specialties, continuing education and affiliation to Primary Care Networks managed by health professionals.
- Free access for all to Primary Care Centres.
- Teams of dentists for systematic oral hygiene for children and adults.
- Shielding our remote and under-served islands with double salaries for doctors and nurses, as well as electronic remote health and medical services.
- Establishment of an Open Hospital for flexible coverage of areas with special needs for periodic or emergency staffing.

Funding Public Health with value in every euro of the Greek taxpayer

- A total ban on money transactions within Hospitals or Clinics.
- EOPYY as a single single payer of doctors and hospitals with exclusive management of all national funds for public health expenditure. Financing of the EOPYY from (a) EFKA, with reduced labour insurance contributions but zero tolerance of black labour, (b) Private voluntary insurance, (c) Sharing of VAT and excise duty to compensate for the impact of our lifestyle on the health system (vaporisation, foods/drinks high in salt, saturated fats, alcohol, sugars); and (d) A special participation fund for legal immigrants, by taxing the benefits they receive and their remittances abroad.
- Rational pricing of health services by EOPYY and private insurers based on the duration of the visit, the examination with technology requiring specialization or laboratory.



"Full reinstatement of health workers who were unjustly suspended, strong compensation for lost wages, formal apology from the government."

Design with best practices from the best international health systems. Management of hospitals by experts and not by party people.

- Hospitals as self-governing non-profit non-profit institutions with an entrepreneurial operating logic, their own balance sheet and combined funding from the state, institutional bodies and private individuals, for measurable and rational expenditure, innovation and competitive, constantly improving service provision. Strategic reorganisation of hospitals (mergers, change of use, co-management networks), technocratic staffing based on CVs, conference control, evaluation (logbook) of residents.
- Health Regions, as NPAs, supervise the hospitals, maintain a uniform code of supplies and equipment, under the supervisory control of the Ministry of Health.
- Unified accounting and administrative computerisation of the hospitals, connection with the Ministry of Health, electronic procurement system and control of orders for material and medicines by the hospital directors and the hospital administrator.

- Participation in the Public Health Committee of the Bioethics Committee for strict control of medical procedures, research practices and vaccine formulations.

Health Heroes deserve quality specialisation, salary upgrading, merit-based employment in line with the needs of the market.

- Promotion of paramedical studies with high demand (nursing, midwifery, medical laboratories, biochemistry), limitation of admissions to medical schools, quality lifelong training, better pay.
- Specialty training with classical clinical medicine, physical examination, use of new technologies, humanistic approach to patients. Postgraduate specialisation and doctoral theses in private institutes with state participation and control. Continuing Medical Education for well-informed doctors as an obligation of the State to society, with triennial refresher training for all medical specialists through seminars, skills training, certification examinations. Scientific development of staff

hospitals with a voluntary overtime bonus for subsidies for seminars and specializations.

- Fees in hospitals: Upgrading the salaries of doctors, nurses and administrators and rewarding them on the basis of financial and clinical efficiency. Guaranteed minimum salaries for all levels of staff, from director to paramedics. Competitive employment of doctors and dentists on part-time or full-time contracts in multiple hospitals.
- Fees for surgical operations with the participation of the National Health Insurance Fund and private insurers, based on prices set by the state.
- Fees to GP practices from the EOPY with a minimum limit and based on the number of patients or examination hours, with a maximum limit of 24 hours. No false statements, no physician fatigue.
- The possibility for private doctors to be involved in all medical operations in the hospital.

Social Policy

"Our weak fellow man is the measure of our civilization".

National Strategy for Diabetes: improving the quality of life and everyday life of millions of Greeks.

- Establishment of a healthy diet with a low glycemic index menu in mass catering and school canteens.
- Glycaemic index labelling on food and beverage packaging, sugar tax on contents.
- Free formulations, blood glucose monitors and insulin delivery devices for low-income, insulin-dependent and juvenile diabetics.

Integrated Policy for People with Disabilities: access, dignity, practical support

- Increased access to public buildings and private practices. Disability requirements in new construction. Decent mobility through interventions in transport, bus stops, signage, pavements. Access to legal information, to the digital world and to work by implementing quotas for recruitment in the private sector, with rewards for employers (reduction of contributions, labelling as an 'Employer of disabled people').
- Special card for disabled persons as proof instead of the reduced continuous display of the CEDAW statement.
- Restoration of disability pensions from the memorandum cuts and the deprivation of the social solidarity benefit. Consistent and timely disability rates. Health services for the disabled, in addition to certification, to proceed with rehabilitation, with reduced pharmaceutical costs and availability in Greece of all approved drugs

of the EU, such as for multiple sclerosis.

- Special financial assistance for people with severe disability, severe mental retardation, cerebral palsy, visual impairment, deafness, deafness, paraplegia, quadriplegia, amputation.

National Strategy for Childhood Disability or Autism: Courage, smiles and meaningful support for child and parents.

- Establishment of mental health and social protection services for children with disabilities and their families to avoid neglect, abandonment and institutionalisation.
- Early educational integration in nurseries and unhindered learning with their peers.
- Coordination between the state and associations for children on the autistic spectrum: special school classes, special parks, free advanced psycho-technical and behavioural education programmes.

National Birth Defenders Strategy:
instead of excoriating,
we anticipate and eliminate the motives
that push pregnant mothers into a very bad
choice that traumatises their own psyche.

- Molecular developmental biology and embryology see the first human diploid cell as a living organism that carries all the genetic information for the entire human body. Within days it multiplies and already in the 4th week of life the heart is beating.
- The embryo is a human being in its own right, the course of its life is entirely in our hands and the responsibility of a human life is immense, all the more so in the case of the decision to possibly take it.
- A comprehensive political response to the problem, beyond the obvious protection of the sacred right to life for all, cannot stand on legal and moral aphorisms or a myopic view of the outcome, but must

heal and eliminate the motives that push pregnant mothers into a choice that traumatises their own psyche.

Protecting the Mother

- Establish a framework of mental health services and real social protection for pregnant women who wish to terminate their pregnancy under the pressure of social parameters.
- Protection and psychological support for pregnant victims of rape or domestic sexual violence.
- Moral and financial support, including full coverage of childbirth costs, for all needy women and couples.

Protecting the Child

- An expanded adoption policy, so that even those pregnant women who would insist on not taking on the responsibility of raising their child would at least give the new life the chance to blossom.

Protecting the Truth

- Checking of every reported palindromic cyst so that before the therapeutic scraping is performed, the reflux is certified by the attending physician and by the physician, the resident and the midwife in charge.

Protecting Adolescence

- Informing adolescents about conception, contraception, abstinence, knowledge of the mystery-magnificence of life creation, with the cooperation of the State and the Church for the respect and protection of human life and dignity. Youth School for the discrete advisory role of the parent to the child, instead of the prevalent methods of school sex education which have had disastrous consequences wherever they have been applied.

Energy

"Climate change appears as an opportunity to change a painful industrial practice for the environment, but the transition hides dangerous pitfalls - worst of all our energy, economic and national dependence."

The "National Energy and Climate Plan" is neither a plan nor a national plan.

- The ESRP serves exclusively the general objectives of Brussels (reduction of greenhouse emissions, promotion of RES), while conspicuously ignoring the No.1 national priority: the reduction of the excessive energy dependence on imports, which is one of the highest in Europe (74% of the European average, compared to 54% of the European average).
- It is practically indifferent to the two thirds of our energy economy, which are hydrocarbons (oil and gas), 66% of which are currently imported. The substitution of imported oil with imported gas reduces pollutants, but keeps the country in energy and economic bondage.
- It is forcibly replacing the lignite we produce with natural gas we import.

- It does not predict, or even set targets, for the oil and gas that Greece can produce in the coming decades. This is not the responsibility of Brussels but solely of the Greek governments.

We are developing a national energy policy with the non-negotiable goal of reducing energy dependence on imports.

- Declaration of an EEZ, immediate exploration and agreements for the extraction of hydrocarbon deposits belonging to the Greek people, for the substitution of oil and gas imports, enhanced know-how, new permanent jobs.
- Increasing the share of renewable sources in the energy mix, with vertical integration and a spatial plan.
- Attracting investment to enable Greece to exploit the strong potential of RES and

to become a centre for the production of "green" hydrogen, the fuel of the future.

- Cancellation of the forced delignification and closure of plants before they reach the end of their operational life - a pernicious logic that of course is not followed by EU countries with ten times the lignite production (Germany, Poland). We have one of the largest exploitable lignite reserves in Europe, 2 876 million tonnes, when we produce and consume less than 5 million tonnes per year. The need to ensure that lignite is produced in an environmentally responsible way - by including costs in the price per kilowatt-hour - and that the transition to a post-lignite era with a high standard of living and environmental protection takes place.
- Accelerating energy interconnection with the eastern island Greece - the only blue homeland in the Aegean.

"Innovation in energy, benefiting the whole society and aiming for a humane and reliable future for our children."

Reducing emissions in transport

- Strong incentives to renew passenger vehicles and reduce exhaust emissions in existing vehicles. At last we must get away from cars that are old, environmentally damaging and dangerous for road safety. The focus on pure electrification is for an elite, while it excludes the average Greek from the benefits of modern automotive technology.
- Smart focus of electromobility incentives on limited range use: urban courier services, taxis, corporate city fleets, small islands.
- Increasing the share of electric railways in passenger and freight traffic. Development of bus services with denser routes, optimum occupancy rates and savings.

Reducing energy consumption in buildings and homes.

- More than half of the houses were built before 1980 with non-existent thermal insulation standards. Today, 2 out of every 3 domestic buildings are among the lowest insulation classes.

energy classes (E-H) and only 2.5% in the high energy classes (A-B). There is similar scope for improvement in office and service buildings.

- Permanent incentives for energy efficiency upgrades in housing.
- Extensive use of geothermal and solar systems in the energy efficiency of buildings (cooling, heating, hot water). Incorporation of high energy efficiency and insulation standards in the General Building Regulation.
- Study of new power plants with a view to providing district heating - for drastic reduction of domestic heating costs and pollution, new jobs, reduced oil imports.

Developing renewable energy sources (RES) with responsibility for the environment and the economy

- Spatial framework for the development of RES, to protect the character of the Greek countryside and islands, clarification of the areas of application, simplification of the licensing procedure.

- Focusing RES in the built environment (cities, RES) close to consumption: reduced transmission losses, enhanced national energy security.
- Focus on solar energy where we have a clear advantage. Establishment with the development of a domestic photovoltaic production industry.
- Wind farms in built environment and cultivated land, certainly outside Natura sites. Construction vertical integration with innovation in softer technologies (e.g. wingless turbines).

The important thing about kilowatt-hours is not the provider, but the origin and the environmental footprint of its production.

- Liberalisation in the distribution of an untaxed good, such as kilowatt-hour, stimulates competitive services but imposes additional administrative, advertising and marketing costs on the consumer.
- The wholesale-retail pricing model should motivate suppliers and consumers to choose domestic and greener energy sources.

Environment and Sustainability

Garbage is not appropriate in our culture. We owe it to our children to produce less and manage it better.

- In Greece, we produce more than 500 kg of municipal solid waste per year per capita, with 80% of it being buried in landfills, which is the worst way to manage waste. Our dismal ranking with the lowest material cyclical index in the EU is the work of euro-land governments that have disregarded the nobility and cleanliness of our ancestors.

No more landfills.

Strengthening quality sorting and processing.

- Radical change in waste management, with reuse (compost), energy production, recycling.
- Municipalities at the forefront of responsibility, by monitoring the implementation of waste sorting bins at source - paper/glass/aluminium/plastic, organic waste (brown bins) - and collection in separate streams. Awards and sanctions for municipalities with

aiming to reduce mixed waste.

- Modernisation of Recycling Material Sorting Centres for delivery in separate streams according to recycling requirements. Support for small municipalities in waste management infrastructure.
- Construction and operation of waste transfer stations and modern waste treatment plants in partnership between the public and private sectors. Mandatory accurate and timely recording of waste data by local authorities in databases to prevent fraud.
- Exploitation of applied research for energy recovery by combustion and chemical recycling.

Recycling

- The EU's much-publicised recycling has relied heavily on exports of waste to dubious destinations in poor Asia - something that cannot continue with the escalating ban on waste imports from Asian countries and stricter controls (Convention

Basel). At the same time, final solutions for the safe storage of toxic waste for the 31% of Europe's nuclear energy production have not yet been found. Close to the hypocritical but energetic Europe, Greece remains passively incapable of taking care of its environment. Let us change that.

- Reduction in the use of plastic: We focus on packaging, which is 40% of all plastic and has the lowest recycling rate. Incentives to encourage the marketing and consumption of products in reusable packaging (metal, glass). Strengthening of contributory recycling with a guarantee refund system for bottles.
- Cultivating recycling awareness with paper bins and plastic/aluminium compactors in schools and large public services. Mandatory recycling free school books.
- Public procurement with additional circular economy criteria: recycled materials, designing products for easy reuse, repair and recycling.

Sustainable development means Oligarchy, Reuse, Recycling. It means delivering more than we were given.

It means that we are not "citizens of limited responsibility".

Special Unit Environmental Crime

Modern environmental crimes go more unnoticed (long-term and indirect damage to the environment and humans) and their investigation is highly demanding in terms of technological, legal, scientific knowledge, controls, documentation and cooperation between services. But the harm is there: disease, environmental damage, contamination of the food chain, reduced human life expectancy. Only a specialised agency with enhanced skills and responsibilities can effectively prevent and suppress the new form of crime that threatens the communities in front of us.

Waste is an economic resource. The aim is to move from the wasteful linear logic of "produce-consume-drop" to a responsible circular economy.

Biotechnology and Nutrition

- Education and economic incentives for a meaningful and productive transition to a more natural diet:
- Reducing genetically modified ingredients, high unsaturated fat and sugar content.
- Increasing food production and distribution with natural seeds that are transplanted and reproduced. There is no question "sustainable development" the need to import each year disposable seeds for our next crop.

Forest! Don't just remember it while it's burning.

- A strong Forest Guard with sufficient personnel and funds for fire protection, control of illegal logging and illegal logging, a permanent reforestation programme.
- The completion of the forest inventory is a constitutional requirement (Article 24(1)). Independent authority for the protection of natural wealth with control over off-plan construction, sewage and waste management.

Organic waste

- Recycling of organic waste (composting) for agricultural use as topsoil.
- Separate (brown) bins for organic waste using compostable bags in households and catering establishments.



COVID-19: The discord virus.

COVID-16 is a painful reality. However, the fight against it has whetted the appetite of many "do-gooders" who, claiming to protect public health, are making self-serving assumptions that insult our intelligence, that the virus is more contagious in holy temples and family businesses than in borders, supermarkets, banks and buses.

Vaccination is a major scientific achievement and has saved millions of lives. Equally undoubtedly, novel vaccines for COVID-16 are puzzling many well-wishers with fundamental differences from what we have traditionally known about vaccines:

- Their commercialisation, with "provisional and " approval by the European Medicines Agency (EMA), is accompanied by an unprecedented domino effect of legal disclaimers by pharmaceutical companies, governments, medical associations and scientific committees. Ultimately, the only person responsible for possible side-effects is the healthy citizen who has to be vaccinated! This kind of shifting of responsibility is only found in desperate patients and in laboratory animals.
- They contain technology that is partly effective for the coronavirus itself, but not thoroughly studied for side effects and especially the long-term effect on the human immune system (and the possibility of autoimmunity), and general bioethical issues have been raised. The media have widely reported overwhelming rates of effortless refusal of vaccination by

The prime minister, the only one in the world to have proclaimed himself the leader of a nation of injected people, unabashedly promotes the imposition of medical procedures without consent - an idea that was condemned at the Nuremberg anti-Nazi trial. Some people do need to "stay home".

This confirms the concerns of doctors and nurses.

- The Council of Europe decided (resolution 2361, 27/1/21) that for Covid-16 vaccines, member states must inform their citizens that vaccination is NOT compulsory and that no one should be pressured by political, social or other means to be vaccinated if they do not wish to be - and further, that no one will be discriminated against because they have not been vaccinated, because of potential health risks or because they do not want to be vaccinated. Yet the government inexplicably and furiously persists in dividing the people and spreading hatred towards those who do not wish to be vaccinated.
- A government that respects its citizens and their individual freedoms would make all types of vaccines available, ensuring non-discriminatory freedom to choose whether, and with which vaccine, each citizen wishes to be vaccinated. Furthermore, a vaccine that does not guarantee the non-transmission of the virus cannot be understood to confer a certificate of immunity to public health. "Safety"? Perhaps, albeit temporary. "Freedom"? Certainly not.

"The government has left the health of the citizens unchecked, trivialized science, refused dialogue, imposed incomprehensible measures that it itself despised, divided our society, broke the mental and economic health of many, insulted and mocked our values. And now, it washes its hands of thousands of deaths of our loved ones that could have been avoided."

What he would do NIKI as a Governmen t;

Health threats should now be included in our economic and social budgets, with measures that keep the economy sustainable whether there is a pandemic or not. Mass incarceration has proven to be not a solution but a postponement of the problem into the future. The strategic continuation of social, educational and economic life requires avoiding congestion in ICUs and the collapse of the health system. Ultimately, we must be able to pass (any) virus with mild symptoms. This means wave-breakers with a strong immune system, primary care, good medication. The (any) vaccine is the icing, not the cake.

Immune Armouring

Focus on the triptych of good nutrition, exercise and good psychology. Support for the media, not to bury the scientific debate, but to promote quality education in good nutrition and physical exercise. Focus on news of courage and hope instead of misery and fear.

Sustainable Economy

Economic misery has not helped anyone's health: open finances, reasonable distances, hygiene measures. Smart store hours to thin out the clientele. Transport with more frequent services, fewer passengers. Entry into the country only with a rapid test. The police in their natural role of preventing and suppressing crime, not issuing fines to family members.

Primary Care

Active support for each new case by recruiting nurses for home care, regular visiting schedule, multivitamin and nutritional treatment for immediate immune boosting before the viral load "breaks out". A patriotic government does not advertise solutions that find scientists divided, nor does it leave the sick person helpless as a cold statistic, with threats of punitive quarantine violation - it helps him or her early on to gently pass the disease and not let it escalate.

Medication

Serious complications are caused by microbes and not by the virus itself. Antibiotic regimens and monoclonal antibody antiserum directly address complications for certain groups. As of 11/2020, such drugs have been approved by the US FDA and are saving lives, while in Greece there has been unthinkable silence from policymakers, resulting in hundreds of helpless victims. Support for research, development and production of medicines by Greek scientific teams that are currently left to the support of third parties.

"As a Government, it would be unthinkable for us to interfere with the way or the time the Church administers the Holy Sacraments. On the contrary, the State would help the Church to implement its

On the contrary, we believe in bringing together individuals with common faith and ideals, with integrity and honesty, with a spirit of cooperation and unity, with a spirit of benevolent contribution on their own merits. Unity for us is unity of well-meaning persons.
